3. Genetics and Autism Spectrum Disorder: Known and Unknowns

In this presentation, Dr. Murali will educate the audience about the current landscape of knowledge regarding the genetic underpinnings of Autism Spectrum Disorder (ASD). Highlights will include polygenic vs monogenic inheritance, chance of developing autism for siblings of children with ASD, recommended genetic tests for children with ASD, nuances of genetic test result interpretation, and illustrative examples of genetic causes of ASD. Dr. Kochel will educate the audience about the national Simons Foundation Powering Autism Research for Knowledge (SPARK) study—the largest study of ASD in history. SPARK will enroll 50,000 individuals with ASD and their biological family members to (a) identify new causes for ASD that inform novel treatments and (b) accelerate the pace of ASD research. Dr. Kochel will highlight the value of joining SPARK and what knowledge has been gained to date.

1. Identifying Genes That Influence Behavior and Neurodevelopmental Phenotypes

There is increasing evidence that genetic factors can influence both behavior and neurodevelopmental phenotypes. Clinically-based genetic testing can often reveal changes in known disease genes that contribute to the development of abnormal behaviors and neurodevelopmental disorders like developmental delay, intellectual disability, and autism spectrum disorder. We have shown that data from these same tests can also be used to identify new disease genes that cause these disorders. These new gene discoveries can lead to improved genetic counseling for families, can change medical management, and provide the foundation from which new preventative and therapeutic interventions can be developed.

This presentation will ignite a passion to help adults with intellectual disabilities satisfy their desire and need to learn to read. While the phrase Reading is Fundamental typically refers to the relationship between reading skills and school success in children, those adults who cannot read have a hunger to be able to experience a good story and share it with others, to keep up with current events, to order their own food off a menu, to read their own birthday cards, to be able to engage effectively on social media platforms, to have that one skill that truly is fundamental to a more independent life. Application of the teaching strategy to PASRR participants and to new HCBS requirements for Individual Skills and Socialization will be explored.

1. Psychiatric Disorders Associated with Epilepsy

This session describes the various psychiatric disorders commonly associated with epilepsy. In fact neurobehavioral disorders are found higher in the individual with intellectual and developmental disabilities. The traditional approach to epilepsy care focuses on the treatment and amelioration of seizures, although this occupies a small sample of the individual's life. This traditional approach does not address many of the issues having a negative impact on the quality of life of the individual. The neurogenesis, symptoms, classification and treatment options are all explored in this session highlighting psychosis, depression and mood disorders.

Individuals under guardianship can experience feelings of disempowerment. 3. STAR – A Novel Approach to Residential Treatment for Autism

Residential treatment is typically viewed as a last resort, yet sometimes residential treatment is the only way to provide the stability, safety and structure required to fully address the needs of the person and the environment. We propose, the STAR program, an early intervention approach to treating individuals with ASD. STAR is an ABA-intensive, short-term residential treatment center-based program (RTC). According to McNellis and Harris (2014), benefits of this type of RTC are numerous including a multidisciplinary approach and a continuum of treatment services, beginning with inpatient care through the transition back into the home environment.

This is especially true when communicating with service providers, family members, and community medical professionals about our observations of people diagnosed with developmental disabilities, including those who struggle with behavioral challenges. This may result in misdiagnoses or a lack of understanding of how to best work with and support others. In this presentation, we will learn to use language that avoids many of these common misunderstandings.

3. Person-Centered Practices: Empowering Staff and Improving Lives

Delivering Person-Centered supports is hard work but doesn't have to be complicated. In this session, Patrick Lane, a Mentor with The Learning Community offers an easy-to-understand plan to move any organization toward best practices. It begins with Person-Centered Thinking Training where supporters learn the mindset and skillsets to actually be Person-Centered. They also learn to organize information in a Person-Centered Description (PCD) which can then be used to inform plans and train staff. To maintain this momentum Person-Centered Coaches, provide on-site support ensuring the plan is followed and that Person-Centeredness remains in the fabric of the organization.
